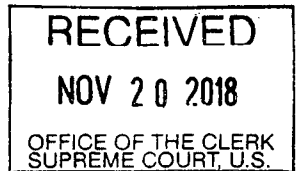
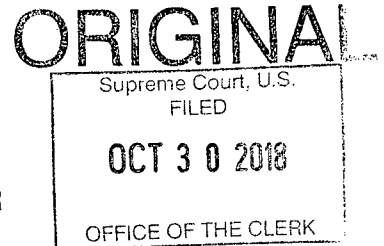

## STATEMENT OF THE CASE

This case is about harassment, privacy violation, intimidation and approachment. On December 24, 2015 I called the dispatcher, she sent Officer Garver to my apartment I let him in I told him somebody is using my identity without my consent because I saw an address on my credit report that I never used it as my mailing address so that's a fraud address. I told him this guy will or William Cheatham got my identity by bullying me by hurting me and beating me up. Officer Garver didn't believe me he said that guy is the biggest drug dealer in town, he start accusing me by asking me did you ever deal drug with him? I said no it's not what you think then he said to me, Tell me you won't be charged for it, I said he was using me and I was tempted, the last time I smoked was July 22, 2015 and I never smoked since then. A week later from December 24, 2015 to December 31, 2015 I called the Dispatcher she sent officer Best a female cop I let her in my apartment she said to me Cheatham! Cheatham! Cheatham! sounds like she was mocking me, I just want to make a report about Cheatham that he took over \$4,000 off of my debit card she didn't seem to believe me, if I could be reimbursed from my debit card Direct Express Card Company she was right about that they won't reimburse me. This officer Derek Garver spread the allegation about me to his police friends. Two weeks later on January 13, 2016 I start getting harassed by somebody from the police when I am just walking to the V. A. Hospital for my appointment I saw a cop with a pistol belt staring at me while I am heading to the Canteen store I went in the store and he went inside walked around me that kind of scared me and then going to my apartment about half way to my apartment there was a car circling me, they've been circling me and I am just walking around the block to do my exercise. When I got back in the apartment, they sent V. A. police officer Salamayran to my apartment to see what I am doing in my apartment, of course I didn't like that I was upset about that I found out his name is officer Salamayran.

## Statement of the case

That guy got no business coming by to my apartment, he knocked & answered the door he asked me Is Michael Chinn here? I said I don't know him and there is nobody by that name in my apartment. I called the V. A. Police Dept. to find out who is Michael Chinn? They said they don't know him and there is no warrant on him. So that means officer Salamayan made up a false name. I like to know what he got on me? I like to know what he has to say about that. I've been getting harassed by alot of unidentified or unknown people around the V. A. campus. On October 4, 2018 going back to my apartment there was a V. A. cop greeted me and I also greeted him he said good! good! good! good! that was around 4 P.M. he doesn't have to repeat himself that's odd. The harassment still going on off and on, I just hope they would stop harassing me. For or about officer Garver that guy got no business spreading the false allegation about me because the confession is coerced or a tricky question that led to coerced.

## REASONS FOR GRANTING THE PETITION

Officer John Talamayan is an accessory to the Conspiracy team of officer Derek Garver his police friends and officer Sierra Best a female cop is part of it. I talked to the supervisor of officer Garver and officer Best, I said to Sgt. Brandau 2 weeks later after I saw your two officers I start getting harassed by somebody from the police. Sgt. Brandau said it's Garver that's got something to do with that not Best. I knew that already it's Garver who started the harassment and got something to do with that, he made it worse by spreading the rumor about me to his police friends. I got news for them or to anyone that I am going to say right now, the one who put me in this apartment is a caseworker from the adult Protective Program Services from the SRS or DCF Welfare where I am currently living in the V.A. apartment for safety reason and I am getting harassed from the police, the cops should be ashamed of themselves, that's all I got to say for now. I'll stop for now.



### CONCLUSION

The petition for a writ of certiorari should be granted.
