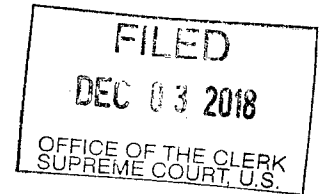

I have been at FPC Montgomery since April 8, 2015. Before that, I was at FCI Butner (NC), a "Low" security federal institution, beginning on or about February 15, 2013. While I was at Butner, I was paid an average of \$33.91 per month. While at Montgomery, I have been paid about \$107.13 per month, all of which has been expended for TruLincs (email) and TruPhone (telephone) and for commissary. I now have about \$197.00 in my inmate account. My military retirement pension and joint assets with my wife are being used for her support.

I am also subject to a restitution judgment of about \$30,000,000. That judgment has not been paid. I understand that the judgment is a lien against my property. Because of that judgment, and because I have been in prison since February 2013, and because I don't have any other income, I believe that I have no income or assets to use to pay court fees or to hire an attorney.
