


Re: Application for Extension of Time to File of Sept.18,2018




Although the Application was sent regular First Class mail with proper postage Prepaid for 3-day delivery marked "Legal Mail", we have reason to believe that quite possibly this mailing has failed to reach your office. Since I arrived at this current location in early July, I have become aware that countless people are reporting that... both incoming mail, but mostly outgoing mail, including legal mail, have not been received in a proper OR timely manner; with some mail NOT EVER being received outside by the addressed recipient. Therefore, it would certainly be appreciated if you could confirm whether or not you in fact received this filing, and when you received it if you did, and whether its approval or denial has just been some oversight. You will likely notice numerous signatures who will bear witness that in fact they know my filing was made; and some who will also attest that some of their own mailings have been mishandled at this facility.





Please find enclosed an Application To Extend Time To File Petition For Certiorari authorized under S.Ct.R 13.5. Sup.Ct.R 22.3 requires the Application to be "addressed to the Justice allotted to the Circuit from which the case arises."

The instant Application from which the case arises is from the Fourth (4th) Circuit on an original appeal to a §2241 Petition of an actual innocence claim. The undersigned is currently unable to ascertain exactly which Justice is now overseer of the Fourth Circuit.

Nevertheless, please forward the contents herein to the appropriate Justice authorized to "extend the time to file a petition for certiorari" (Sup.Ct.R. 13.5).
