
Dear Clerk:

It was not until around October 18, 2018, that was able to have my family locate and mail some of the files that I then recreated to writ and mailed in to your office, and due to the letter that your office sent back to me with the said motion I resubmit this writ of cert. Pursuant to Supreme Court Rule 30.4, I request an extension of time and or to file and out of time writ of Cert date effective as placed in the prison mail room on this day October 10, 2018.

As noted below, copies of this request are being sent to all other parties.




APPENDIX 3

DECLARATION UNDER THE PENALTY OF PERJURY 28 U.S.C 1746

I declare under the penalty of perjury that the foregoing is true and correct.

- 1) I, Andreco Lott; prison ID; #27068-177 and being over the age of 18 years old, do state as fact that on;
- 2) August 22, 2018 until September 5, 2018, that FCC Forrest City Federal Prison was on an institutional lock down. see ATT: 1
- 3) That during this lock down, there was a prison wide shake down and that during that lock down, my legal work and other personal property was thrown away.
- 4) The legal that is important to this case was in fact a part of the property that was thrown away and misplaced.
- 5) I state that in addition to the legal that was taken, other legal documents and court addresses where also held for a additional 10 day past my filing deadline to ask for an extension. SEE ATT: 2 and 3
- 6) Some of the said property was returned on September 6, 2018 accept the files/documents need to file the pleadings now being filed.
- 7) I declare that it was not until October 8, 2018 that I was able to have my family members locate some of my legal work that I had sent home over the years for records keeping proposes. SEE ATT: 4
- 8) These files where used to attempt to recreate the pleads being submitted.
- 9) I further declare that it was Forrest City Prison staff members Mrs. Banks, Mrs. Brooks and other unnamed staff, that cause me to miss my filing dead line(s), by their actions.
- 10) Due to the prison lock down, I was confined to my cell and unable to use the law library and education department to work on my case and pleadings.
- 11) I was only given a Memorandum to present to this court by prison staff Mrs. Farris (counselor) on October 23, 2018 after many attempts at such documents. SEE ATT: 5

As the result of a major incident at the medium facility of FCC Forrest City, the institution was placed on lockdown from August 22, 2018, through September 10, 2018. During this lockdown, inmates were not allowed to conduct routine daily operations including making copies in the legal law library, attending mailroom open house, or weighing mailing packages designated for property mail-out. The inmates had limited access to telephone, e-mail, and TRULincs services.



