

This docket entry was made by the Clerk on Thursday, November 29, 2018:

MINUTE entry before the Honorable Rebecca R. Pallmeyer: Defendant Johnston's motion for reconsideration [261] is denied. The government will be expected to prove, as a matter of fact, that the deposits of the Byline Bank are covered by federal insurance. The court stands by its determination, explained in an earlier ruling [153], that there was probable cause for Defendant's arrest. The court declines to order the Marshals Service to serve subpoenas absent a showing that standby counsel is unable to serve them. In fact, standby counsel reported in open court that he has served subpoenas by certified mail. Defendant is free to file motions to compel compliance with any subpoena that has been properly served, but for which there was no timely response. party's disagreement with the court's rulings does not support disqualification of the judge.
Motion for hearing on second motion to quash [251], and motion to supplement [257] are
denied for the reasons stated in open court. Defendant's motion for reconsideration [159]
is denied, as Defendant has offered no sufficient basis to revisit the court's previous




