**QUESTION PRESENTED****DATE: 11/20/2018**

1. IS it illegal or wrongful for Community Mental Health to be holding Angel Bartlett in corrective programs even when there is no open probate to hold Angel? CMH sends Angel a bill or has some other reason to contact Angel to make her come in to deal with the problem that is NOT for mental health and they put her in Community Mental Health "CMH". Then they do mind control and block out all wrong doing of the people who have been killing Angel. 18 US Code 241, 18 US Code 1113, 18 US Code 1117, 18 USC Ch. 13: CIVIL RIGHTS

THEY ARE STILL USING THE INTERNET AND RADIATING ANGEL IF SHE GETS ON FOR MESSAGING OR BROWSING. THEN SHE GETS RADIATED EVEN THOUGH THE SUPREME COURT OVER TURNED THE BAN.

Supreme Court opinion in *Packingham v. North Carolina*, holding 8-0 that a North Carolina law prohibiting previously convicted sex offenders from accessing or using “social networking” websites violates the First Amendment.

North Carolina G.S. §14–202.5 makes it a felony for registered sex offenders to “access a commercial social networking Web site where the sex offender knows that the site permits minor children to become members or to create or maintain personal Web pages.” The definition of “commercial social networking” site has four attributes: \* *Internet Exceptionalism*. Just like the Supreme Court did in 1997 in *Reno v. ACLU*, the judges embrace Internet exceptionalism (see, e.g., Justice Alito’s “Cyberspace is different from the physical world”). However, the nnmne majority and concurrence disagree about whether the Internet’s differences are good or bad.

Angel got framed so they started attacking her. Angel B. didn’t know what to do so she called places to figure out why they were attacking her.

Community mental health and the police were terrorizing Angels family and making everyone hate her. They finally blasted her with wave energy and she started shaking. They made her think her house was going to blow up. Angel B. got put down as a terrorist wrongfully and also wrongfully as a caller saying a terrorist attack occurred when they claim none did but in fact there was, and no one did anything about it. They moved Angel to her moms and then started attacking her there. Angel has photos of the radiation that was placed on her house with Angel and her twins inside. This was reason for them to take the twins away from Angel and put her in the mental hospital. They then had Angel B. start writing to places in agencies to correct her problems. IN February 2014 Dr. Mauli Verma ordered a drug screen right before Angel B.'s baby was born so they would have good reason to steal the baby and put her down even more. They took the baby with false drug screen and it was corrected on file after the baby was removed from Angel B. care. They then put Angel down as mentally ill again and ordered her to CMH, but Angel refused to go instead she went to every agency she could and applied to get clearance to take them down. That is why we are in court. Angel learned what they did Angel can't get a job until they all release her, and this give them motive to hold her. Angel loses an appeal and the military attacks her and they end up dead. Angel gets radiation put on her from framings. They use horrible tactics. They put Angel in mental confinement at every case hearing and this alone causes Angel to not sustain and then the case gets denied. SO, if CMH wants to put it on all the other places it is CMH that makes the false case that has been ongoing to sustain because CMH uses foul tactics to destroy Angel B. mental state in court.

Angel had an appeal just recently and she got a bill in the mail for \$98.46. The bill was for a FOIA that Angel B Requested and they sent back all the files that Angel previously sent. Why would Angel want to purchase her own information at 23 cents a copy? They did this only to get Angel agitated so they could put her in services to then give a mental order of delusional trial and then drop her appeal she had in progress. This then made Angel again get a death warrant and Angel gets radiated. Community Mental Health is doing conspiracy to commit murder and have done attempted murder. They will counter and say they put her in services or CMH to make sure she doesn't get radiated but that is not the truth. If the case didn't get denied, then she would not get the lethal radiations.


## REASON FOR GRANTING THE PETITION
