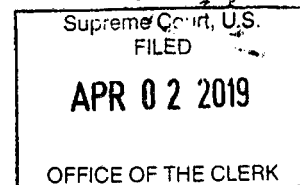

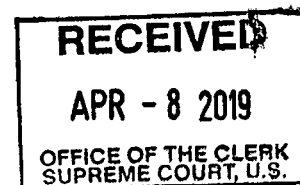

PETITION REHEARING OF WRIT OF CERTIORARI




