


MR. WHITMAN'S MOTION REQUESTING AN EXTENSION OF TIME
TO INCLUDE DECEMBER 25, 2018 TO FILE HIS
WRIT OF CERTIORARI WITH THIS COURT

Mr. Whitman received a denial of his appeal from the Eleventh Circuit Court of Appeals dated August 3, 2018. Mr. Whitman is preparing his Writ of Certiorari to file with this Court and is doing so as an indigent, pro se and incarcerated individual. As such, Mr. Whitman must overcome the many obstacles associated with prison life that hinder the preparation of legal filings and an otherwise earlier filing. Therefore, Mr. Whitman requests an extension of time to include December 25, 2018 to file his Writ of Certiorari with this court.

Here at FCI Coleman Low federal prison, where Mr. Whitman is incarcerated, inmates are subject to numerous recalls on a daily level. These recalls result from staff shortages, staff training, census counts, fights, cutting of the grass, and most recently the daily thunderstorms we have. These recalls can often turn to lock downs and all affect Mr. Whitman's ability to access the education department where the 12 law library computers, the one copy machine (which is often broken or out of paper) and the 6 functional non-memory typewriters are located and shared by over 2,000 inmates housed here.

As such, Mr. Whitman requests an extension of time to include December 25, 2018 to file his writ of certiorari with this Court. He believes this time will allow him to overcome the known and unknown obstacles associated with prison life that prevent an otherwise earlier filing with this Court.




