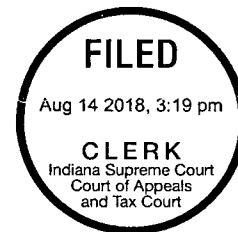






**Order**
