

**SWORN AFFIDAVIT**

**SUPREME COURT OF THE UNITED STATES**

To the Honorable Clerk of the Supreme Court of the United States, I, Karreem Wiley #327305, being of sound mind and reasoning, Declare as True in the presence of the below-signed parties on the below-said date that on April 15, 2018, the South Carolina Department of Corrections (SCDC) declared a statewide mandatory lock-down of all of the institutions in its jurisdiction including the institution that I reside, McCormick Correctional Institution.

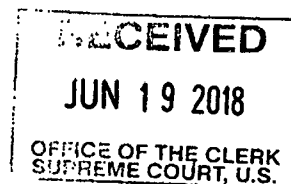
This mandatory, complete institutional lock-down was instituted as the response to the violent riot that transpired at Lee County Correctional facility which gained national media attention as the second deadliest prison riot in U.S. history. For this reason all normal functions and operations of the institutions facilities, including the law library and legal mail privileges were either completely discontinued or limited.

As of today SCDC is still on lock-down status and this has prevented my access to the proper resources and law library clerk instruction to thoroughly research my case and submit my petition for writ of certiorari.

I received the denial for the appellants motion for appeal reconsideration from the Fourth Circuit Court of Appeals on March 29, 2018. Due to officer shortages and unforeseeable events that have been occurring more frequently here at McCormick which has pushed me to the boundaries of my time deadlines at every stage of my appeals.

The occurrence of these adverse circumstances is beyond my control or anything I could foresee. It is essential to the proper preparation and submitting of my writ of certiorari, in accordance with the rules and procedure of the Honorable Court, that I be granted an extension of time.

My case contains numerous Constitutional violations committed by the respondent. I need to investigate and search for Supreme Court of the United States cases pertaining to Sixth Amendment "confrontation clause" violations.



One of my biggest issues is the State's failure to make my codefendant/alibi witness available to testify at my trial. I also need more Supreme Court cases that pertain to Sixth Amendment "effective assistance of counsel" claims as well as Fifth Amendment Due Process and Sixth Amendment Brady Rule violations.

Another major meritorious issue in my case is the failure of the State to provide all of the Discovery evidence in my case and if the State shielded my codefendant from prosecution in my case by withholding the fact that she set me up to take the fall and later received immunity to conceal the admission of her testimony to her actions at trial.

Without adequate access to the law library and the library clerks to help me in the process, I will be deprived yet again of due process and an opportunity to present the truth to the courts. The Supreme Court of the United States is my last shot at this.

For this reason I humbly submit the affidavit requesting a thirty (30) day extension of time to submit my writ of certiorari in the hopes that no other extraordinary circumstances nor unforeseeable events that are beyond my control would arise in the future.

I pray the Honorable Court would understand the legitimate merit to my request and grant me an extension.

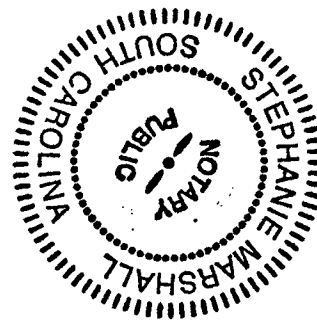
