BASED ON THE FILE, RECORD, AND PROCEEDINGS, AND BECAUSE:

1. On November 6, 2018, petitioner filed a petition for a writ of prohibition. On November 9, 2018, this court issued an order directing petitioner to (a) pay the \$550 filing fee or file with the clerk of appellate courts a copy of the district court's order granting leave to proceed in forma pauperis (IFP) in the court of appeals; and (b) serve the district court judge with a copy of the petition for prohibition and provide proof of service.

2. According to the district court register of actions, petitioner filed an application to proceed IFP in this court with the district court on November 14, 2018, requesting a waiver of appellate court filing fees and for payment of transcript preparation costs. Petitioner filed a second request with the district court on November 19, 2018.

3. On November 27, 2018, the district court issued an order finding that petitioner is entitled to proceed IFP, and granting his request for payment of transcript preparation costs.

4. On November 28, 2018, this court received a motion from petitioner dated November 21, 2018, requesting an extension of time in which to provide this court with a district court IFP order. In support of this motion, petitioner indicates that he had not received a response to his IFP requests from the district court as of the date of his motion.

5. Because the district court register of actions indicates that the court has granted his request to proceed IFP, an extension of time is unnecessary and we deem this deficiency in the petition to be satisfied.


6. On November 28, 2018, petitioner filed affidavits of service of his petition for a writ of prohibition on the district court judges involved in this matter.

IT IS HEREBY ORDERED:

1. Petitioner's motion for an extension of time is denied as unnecessary.
2. The deficiencies noted in this court's November 9, 2018 order are deemed satisfied.
