

I declare under penalty of perjury that the foregoing is true and correct.



PETITIONER'S AFFIDAVIT IN SUPPORT FOR
LEAVE TO PROCEED IN FORMA PAUPERIS

My name is John Paul Galbraith and I am 50 years of age. I have been incarcerated for nearly twelve years, and I am a prisoner in the State of Texas. In Texas, prisoners do not earn money for the labor they do within the prison system. I rely on family support to purchase hygiene, commissary, phone minutes to call my elderly parents, and pay for medical co-pay of \$100.00 a year. I am indigent without any source of personal income and I am unable to pay the Court fees to file my writ of certiorari. If the Court should GRANT my certiorari, I am unable to hire an attorney to represent me on appeal.
