



Constable Abbott had been talking to an American male in the next Hut.

The male was yelling out about his rights, about being assaulted and his American rights to press charges.

The male had long shorts and no shirt on.

**YOUR CASES**

**Immigration**

You may not be eligible to apply for humanitarian consideration on a section 1534 deportation order because 42 days has expired since your visa expired. However, on your instructions that the law actually requires that you be allowed in New Zealand to defend the charge which arose before your visa expired I have applied for Legal Aid anyway.

Please now find attached Application to Appeal to the Immigration Appeals Tribunal. You will see I have filled as much of it out as I can.

Please finish what you can of the form, sign it and ask the Prison to Fax it back ASAP.

**Criminal Charges**

The Crown have now laid three fresh indictments which replace the Summary Assaulting and Resisting Police charges. My advice is this change is irresistible since the alleged offending happened as part of an ongoing incident, and I am not particularly concerned anyway. It does mean however that if you continue to defend the Police matters I need more information specific to them e.g. self-defence. Perhaps the Prison will let you fax up a one page Brief.

Finally, the technology has only just allowed us to communicate by video link. Please indicate times when the Prison will allow you to chat.
