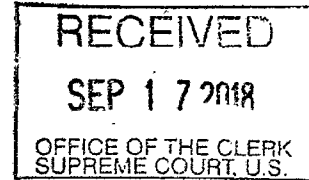

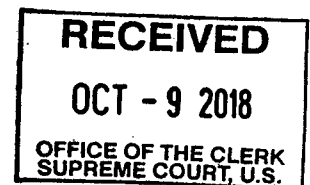

Re: MOTION TO PROCEED IN FORMA PAUPERIS AND TO EXTEND TIME TO
FILE IN FORMA PAUPERIS

Dear Justice Alito:

It is unfortunate that I am being forced to replay 2014 in your Court by a bank who has refused guaranteed pay-off payments since 2010. It was \$150,000+ in 2010; \$165,000+ in 2011 and is presently \$335,000+ in 2018.

Long History of Being Granted in Forma Pauperis

I present this letter brief with evidence of U.S. Court of Appeals granting of *in forma pauperis* status (Exhibit 1) and a Certification of Truth that Your Honor granted me *in forma pauperis* status in 2014 (Exhibit 2). I have also been granted the same by the U.S. Tax Court in 2014 and in other state and federal courts.

A Certification of my current financial status with an active financial disclosure form is not enclosed with this petition for one major reason:

Eviction by a Corrupt Bank

After 9-years of successfully preventing my home from being stolen by this corrupt bank, who had problems with their loan portfolio after the Financial Crisis of 2007-2008 and chose to prey on me in February 2009 rather than fix their problems under new management, I was evicted from my home yesterday after a court house auction that has all the earmarks of "bid rigging".

U.S. Trustee Committed Perjury

The fact that the U.S. Trustee and an appraiser perjured themselves in official court documents lends credence to my claim. When I file an amended petition, this latest extra-legal encroachment on my civil, due process and property rights will be briefly examined to support my claim.

Extraordinary Circumstances to Overcome

Prior to today, I have spent the last 10-days packing bags and removing our belongings as well as those of my deceased mother and her brother who belongings we inherited. I should have been completing and filing my Writ of Certiorari. If I am required to provide a filled-out form because this Court of its Clerk believes I might be better off than in 2014, I will file one. In short, I am worse off. I will shortly lose my house, even though I presented a \$500,000 Reverse Mortgage offer to the U.S. Bankruptcy Court who had offered this proposal and then expanded upon it (Exhibit 3). The Final Order and Judgment from Chancery Court to the New Jersey Supreme Court involved violations of federal law which this petition promises can be corrected by granting this writ, including the possibility of this court making a unique, highly public-beneficial precedential ruling regarding regulatory and judicial misconduct. No one wants me to pay the bank. The best way to get rid of me and finally feel comfortable that Lynn Smith will be too crushed financially, too crushed emotionally to move forward with an attorney and reclaim my home and my wife by exposing regulatory misconduct starting in September 2005 and continuing through until the present day. I am barely getting this off before the deadline.

The Focus of My Petition

The focus of my petition will be on how the respective lower courts, including the New Jersey Supreme Court, knowingly violated federal law. However, in this case there will finally be presented, as opposed to my 2014 petition, an opportunity for the Supreme Court to make a precedential ruling with significant positive civil and material rights benefits for litigants and reinforce the intent of the Constitution which has been relativized in my case.

The area impacted will be judicial and regulatory immunity.

Parties to Action

The party to this action is the same as in 2014: Manasquan Bank. Other interested parties will be added in an amended filing or the one I request be filed at an extended date. At present, my papers and templates are in storage which was made extra difficult by the onset of Hurricane Florence.

Please grant this motion for the relief I need and for those similarly abused by a New Jersey-based state and federal court system that is corrupt and has a clear inability to self-police.


CERTIFICATION

Lynn Smith, of full age, hereby certifies as follows:

1. I resided at 409 St. Clair Avenue, Spring Lake, New Jersey 07762 for thirty-years until yesterday and now live in Room 411, Renaissance Suites, Neptune, New Jersey.
2. On April 25, 2013, recognizing my indigent status, my motion to proceed in forma pauperis was granted by the U.S. Court of Appeals, Third Circuit. See Exhibit 1.
3. In the Spring of 2014, recognizing my indigent status, my motion to proceed in forma pauperis to the U.S. Supreme Court was granted by Your Honor. Since being granted indigent status by the Third Circuit and Your Honor, my financial situation has declined significantly. In my amended filings, either I or a pro bono attorney will document the above to any extent Your Honor requests.
4. I am not requesting a 60-day extension to file, just 2-3 weeks to enable me to access all of my records currently in storage.

I hereby certify that the foregoing statements made by me are true. I am aware that should any of the foregoing be willfully false, I am subject to punishment.
