ORDER

Because the District Court granted Hayes' motion for an extension of time to appeal, we have jurisdiction to consider his request for a certificate of appealability. The request is denied because jurists of reason would not debate the District Court's determination that Hayes' claims lack merit. See 28 U.S.C. § 2253(c)(2); Miller-El v. Cockrell, 537 U.S. 322, 336 (2003). In particular, Hayes has not shown that the District Court arguably erred in determining that neither his trial, nor his appellate counsel rendered ineffective assistance. See Strickland v. Washington, 466 U.S. 668, 687 (1984). Reasonable jurists would not debate the District Court's determination that his convictions were not obtained in violation


of the Double Jeopardy Clause. See Blockburger v. United States, 284 U.S. 299, 304 (1932); United States v. Barrington, 806 F.2d 529, 535 (5th Cir. 1986).
