

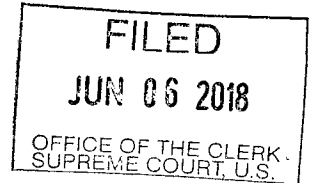




MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

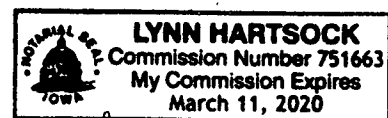
The petitioner asks leave to file the attached petition for writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.


The petitioner was determined to be indigent during the course of his state court proceeding, and the court below appointed counsel pursuant to Iowa Code §§ 815.9 & 815.10
