

With this I am expected to pay my hygiene expenses (toothpaste, toothbrush, deodorant, soap, shampoo, etc.), medical expenses (\$13.80/mo. acid reflux medicine, allergy medicine, etc.), and legal expenses (pens, paper, envelopes, copying:\$0.25/pg., and postage). If you are not indigent and lack the money you must go without. You may be punished if you do not maintain acceptable hygiene. I am also limited to printing 50 pages per week.
