**MOTION FOR LEAVE TO PROCEED
IN FORMA PAUPERIS**

TO THE HONORABLE JUSTICES OF SAID COURT:

COMES NOW the Petitioner, TRAVIS BUCKNER, by and through his undersigned counsel and hereby moves this Honorable Court to allow him to proceed in forma pauperis, pursuant to Rule 39, Supreme Court Rules, and pursuant to the

Criminal Justice Act of 1964, 18 U.S.C. Section 3006(a), and as grounds therefore would state as follows:

1. The Petitioner seeks leave to file, in forma pauperis, a Petition for Writ of Certiorari to the United States Court of Appeals for the Eleventh Circuit, seeking review of said Court's opinion of October 9, 2018 affirming Mr. Buckner's sentence.

2. The Petitioner was convicted in the District Court for attempted aggravated sexual abuse of a child; aggravated sexual abuse of a child; attempted aggravated sexual abuse of a child pursuant to 18 U.S.C. 4. Pursuant to Rule 39, Supreme Court Rules, the Petitioner respectfully prays this Court allow him to proceed in formal pauperis. The Petitioner has not sought to proceed in forma pauperis prior to this petition.
