MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS



O R D E R

At the court's direction, the clerk previously located and, via ruling letter, appointed counsel pursuant to the Criminal Justice Act, 18 U.S.C. § 3006A.
