
This matter before the court is the application of petitioner for a preliminary and permanent injunction to release the petitioner from being a ward under the Guardianship of the State and to be released from the unlawful restraint of the care and custody of the North Carolina Department of Public Safety, filed on November 20, 2017, which the court interprets to be a Writ of Habeas Corpus.

Upon examination of all records attached, and reviewing all of the evidence, the court finds that the petitioner is confined by virtue of a lawful order of a court of competent jurisdiction; that the petitioner is not unlawfully restrained of his liberty; that during the time which the petitioner may be legally detained has not expired; that the allegation set forth in the petition do no constitute probable grounds for relief, either in fact or in law, by way of habeas corpus; and that the petition should be summarily denied.

THEREFORE IT IS ORDERD THAT

1. The petitioner's petition be summarily denied;
2. A copy of this judgment be forwarded to the petitioner, the District Attorney, and the custodian of the facility where the petitioner is confined.



The court finds that there is no question of fact or law to be determined, therefore, no appeal is necessary herein. The motion is denied.




