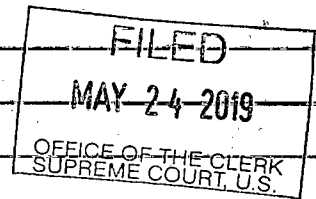
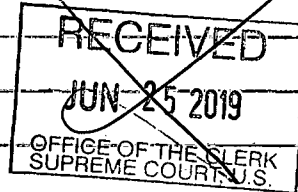

Petition For Rehearing

PURSUANT TO SUPREME COURT RULE 44.2 THE PRO SE PETITIONER, William Edward Cloninger ("Cloninger"), IN GOOD FAITH RESPECTFULLY petitions this Honorable Court FOR REHEARING ON THE GROUND THAT THE COURT HAS OVERLOOKED OR MISAPPREHENDED IMPORTANT POINTS OF LAW OR FACTS IN HIS CASE. IN SUPPORT AS TO WHY THE COURT SHOULD GRANT THE PETITION FOR REHEARING, CLONINGER STATES:

IT APPEARS THAT THE COURT HAS IN SUMMARY DENYING MR. CLONINGER'S PETITION FOR WRIT OF [C]ERTIORARI OR [M]ANDAMUS, TREATED IT AS A [M]ANDAMUS WHICH IS IN ERROR. MANDAMUS IS AN EXTRAORDINARY WRIT THATS USED WHEN THERES NO OTHER REMEDIES AVAILABLE TO COMPEL THE LOWER COURT TO PERFORM A SPECIFIC MINISTERIAL DUTY THAT IT OTHER WISE WOULD NOT PERFORM. THEREFORE, MANDAMUS IN THIS CASE IS NOT THE PROPER WRIT TO REVIEW THE FINAL ORDER ENTERED BY THE ELEVENTH CIRCUIT COURT OF APPEAL, CASE NO: 18-10905, DISMISSING MR. CLONINGER'S CASE, PURSUANT TO 11TH CIR. R. 42-1(b).

CERTIORARI IN THIS CASE IS THE PROPER WRIT FOR THIS COURT TO REVIEW MR. CLONINGER'S CASE IN WHICH THE ELEVENTH

Circuit Court of Appeal has dismissed Mr. Cloninger's appeal cause, Mr. Cloninger was unable to file a personal financial statement of his personal bank account. (See Attachment A.) Due to no fault of Mr. Cloninger, and due to government interference, Mr. Cloninger was unable to obtain from personal officials, after numerous tries, a copy of his personal financial statement. (See Attachment B. Mr. Cloninger's Affidavit).

It also appears that the Court has clearly overlooked the facts as mentioned above, that the Eleventh Circuit Court of Appeal denied Mr. Cloninger's appeal cause, Mr. Cloninger was not able to file a copy of his personal bank account financial statement (See Attachment A.) which was caused by government interference by personal officials not providing Mr. Cloninger with a copy (printout) of his personal bank account financial statement, after he requested that a copy be sent to him numerous times. (See Attachment B. Mr. Cloninger's Affidavit).

Wherefore, based on the foregoing facts and constitutional authority cited herein, should grant the petition for writ of certiorari and remand his case back to the Eleventh Circuit Court of Appeal, to hold an evidentiary hearing on the matter was there government interference in the case or deprive the filing fee and allow Mr. Cloninger to proceed without cost.

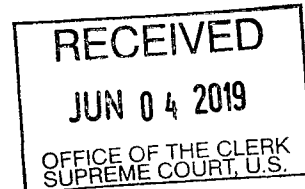
