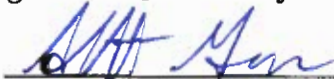

In Macri's previous Illinois circuit proceeding, she was eligible for a public defender, based in her financial situation, but her sister paid for a private attorney instead. **AFFIDAVIT OR DECLARATION

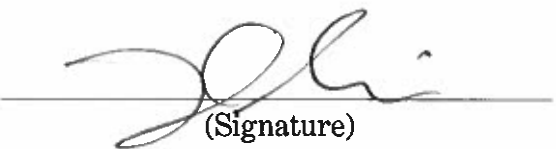
