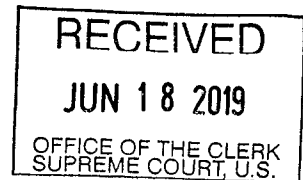

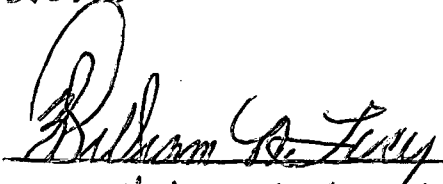

A CIVIL ACTION OR APPEALING A CIVIL OR CRIMINAL JUDGMENT FOR THE REASON THAT THE PRISONER HAS NO ASSETS AND NO MEANS BY WHICH TO PAY THE INITIAL FILING FEE... SEE 28 U.S.C.S. §1915 (B)(4)
