I am a prisoner. Even with a job the income is de minimus. I am at \$1.25/hr (gross), of which I only receive 75% at best. With this I am expected to pay my hygiene expenses (toothpaste, toothbrush, deodorant, soap, shampoo, etc.), medical expenses (\$13.80/mo acid reflux medicine, allergy medicine, etc.), and legal expenses (pens, paper, envelopes, copying:\$0.25/pg, and postage). If you are not indigent and lack the money you must go without. You may be punished if you do not maintain acceptable hygiene. If you need more you are out of luck (or must acquire them from others). Limited to printing 50 pages a week.
