



Affidavit

I have actively sought employment since being laid off from HSAG on 12/10/18, due to lack of funding. Since then I have made utmost effort to resolve the issue and gain employment, but unsuccessful. I've applied to nearly >500 jobs, attended events for prospective employment opportunities. I have nearly \$310,000 US Dept of Education Fedloan Servicing, federal student loan. My grace period ends on 02/28/19, and \$2100 is due on 3/11/19, to which I plan to apply to forbearance. My credit damaged; as due to financial circumstances I am defaulted on all of the credit cards (~\$25,000) since my former transfer offshore medical school became defunct, which led to collateral damages and there was an error with respect to US DOE Federal loan funding (from 2015 to 2018). That was the only medical school I was accepted to, without USF MCOM correcting its errors from my transcript and status. Nearly 15 offshore medical school were under investigation by ECFMG; and about 10 of them were removed from sponsorship from ECFMG in 2017. The medical school was not a Title IV loan recipient, hence, suggested using credit and other venues for tuition related purposes for education and living expenses (including partnerships/affiliations with online U.S. accredited schools for living expenses). I have pretrial conference/mediation for one of the credit card companies on March 18, 2019.

Since my dismissal in May 28, 2013, I have requested USF MCOM General Counsel for correction of my transcripts attributed to their administrative error and status in a letter and several meetings with former Vice President of Educational Affairs, Dr. Monroe (May 2013 to October 2013). After that, a new administration was put in place at USF MCOM, thus requested the plea in Petition for readmission proceedings from January 2014 to August 2014, US Dept. of Education OCR Early Resolution and Investigation from September 2014 to April 2015 and Demand letters 1 and 2, cc: Florida Financial Services Risk Management from May 2015 to December 2015 and throughout the litigation since lawsuit filed on January 2016. For reasons stated below, and also to the fact that the Judge presiding over my case is a father of Attorney General for Florida. I felt this could impose a conflict of interest situation, when elections were going on during the time of when Petition for Panel rehearing was filed. Please note: my intention is not to endorse any political position. I primarily felt based on context of the situation, that this was a difficult position for any student/litigant. Thus, I reached out to Secretary of Education on October 24, 2018; that I am humbly requesting US DOE OCR to resolve this internally and reopen my former OCR complaint, OCR Case no. 04-14-2487, as that was also suggested by Judge Sweeney at the Federal Court of Claims (17-1955). The letter to Secretary of Education dated October 24, 2018 was not handled appropriate and sent to wrong place and eventually ignored. I resent the letter via email directly to Secretary of Education's email. Correspondence was received of the notice, but no action

has been taken as of date. The merits for reopening the case and the new cause of action (Title VI) was reviewed by US Dept of Ed. Office of Inspector General in July 2018; and forwarded the information to US DOE OCR of Atlanta, but no action was taken (OIG Complaint # C18HW03308).

During recent government shutdown, US DOE OCR customer service office, called me to which I requested permission to speak to USF MCOM officials to resolve this internally, besides resorting to US Supreme Court. I was given permission on Jan 2019 to contact the University officials; however, USF MCOM denied to meet to resolve the situation.


As per my financial state; all of my belongings are in storage in Chicago, IL; as I cannot afford housing nor can I afford moving expenses to bring them back to Tampa, FL. I am barely surviving with minimal necessities to stay afloat. It is a challenge to receive job opportunities that are not of conflict of interest with this case. However, with a father whose has been financially strained and has had two emergency heart surgeries since dismissal from medical school; I've tried my best to not burden my family as they are already indirectly suffering. They may have also suffered from retaliation for me pursuing this case, to which I was given no choice. As stated above, I have tried my utmost to negotiate, painstakingly exhausted administrative remedies with good faith and begged to resolve this internally based on context of the situation, especially being a minority of an endangered class, per se. However, it has been unsuccessful. There is a

reasonable suspicion as for safety; that there is retaliation for pursuing this cause of action. For example, when pleadings are filed for this case; ex. suspicious vehicle attacks to family members (within two days of filing petition for panel rehearing on October 24, 2018; two family members were attacked, “run off” on October 25 and 27, 2018), bank accounts frozen, October 18 (during the week of petition for panel rehearing was due). For this instant filing to USCA Sup. Ct., there were two incidents of robberies during the week of when this pleading was due and petitioner’s financial state is completely depleted. Petitioner is from a minority community; she is afraid that the community could be retaliated, as it is common in history for minorities to be persecuted/retaliated during contraction phase of the economic cycle (whether they are wealthy or poor). As everyone can be impacted. Suspicious behavior reported to Tampa Police.

Petitioner has also legally changed her name on January 17, 2019 from Nausheen Zainulabeddin to Alia Merchant.
