MR. SCARLETT'S MOTION REQUESTING AN ADDITIONAL 60 DAYS
TO FILE HIS WRIT OF CERTIORARI WITH THIS COURT

Mr. Scarlett received the denial of his appeal from the Court of Appeals for the Eleventh Circuit dated June 22, 2018. As such, he has until September 22, 2018 to file for writ of certiorari with this Court. Mr. Scarlett is proceeding with his legal filing as a pro se and incarcerated individual. As such, Mr. Scarlett must overcome the many obstacles associated with prison life that hinder an otherwise earlier filing. Therefore, he requests an additional 60 days in order to overcome these obstacles and properly prepare his filing with this court.

Here at FCI Coleman Low federal prison in Coleman, Florida, inmates are daily subject to recalls and lockdowns for reasons to include staff shortages, staff training, the cutting of grass, fights, census counts, institutional

counts, and most recently are the daily thunderstorms that are prevalent in Florida this time of year all result in lock down situations for safety reasons. And, there are often times when inmates are never informed of the reasons for the recalls and lock downs.

All of these combine to limit inmates ability to access the education department where the 12 law library computers, the one copy machine (often broken or out of paper) and the 6 functioning non-memory typewriters are housed and available to the over 2,000 inmates housed here. This limitation impedes Mr. Scarlett's ability to prepare his legal filing and he requests a 60 day extension in order to overcome these known and unknown obstacles and properly prepare his filing for this Court.


