**MOTION FOR LEAVE TO**  
**PROCEED IN FORMA PAUPERIS**

COMES NOW, Alberto Sostre-Cintron, Petitioner in the above entitled case, and respectfully moves for leave to proceed *in forma pauperis* upon filing his Petition for Writ of Certiorari to the United States Court of Appeals for the First Circuit, lodged concurrently herewith.
