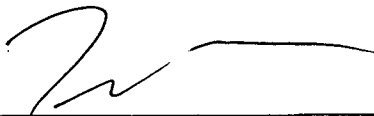

I have separate litigation against the City of New York partly due to my having been viciously assaulted on 7/2/16 that caused me to sustain a concussion and memory loss and that materially sabotaged my ability to perform well during a job interview on 8/18/16 for a job that would have paid me \$450 daily.
