COUNT 1: KEITH JERMAINE MYLES on or about March 8, 2015, in the County of Palm Beach and State of Florida, KEITH JERMAINE MYLES, a person 18 years or older, did unlawfully commit sexual battery upon COURTNEY MCKAY, a person 18 years of age or older, without that person's consent, by penetrating and/or having union with COURTNEY MCKAY'S mouth with his penis, and KEITH JERMAINE MYLES coerced COURTNEY MCKAY to submit by threatening to use force or violence likely to cause serious personal injury to COURTNEY MCKAY, and COURTNEY MCKAY reasonably believed that KEITH JERMAINE MYLES had the ability to execute the threat, contrary to Florida Statute 794.011(4)(b) and (e)2. (1 DEG FEL)

COUNT 2: KEITH JERMAINE MYLES on or about March 8, 2015, in the County of Palm Beach and State of Florida, KEITH JERMAINE MYLES, a person 18 years or older, did unlawfully commit sexual battery upon KATHERINE A GOULD, a person 18 years of age or older, without that person's consent, by penetrating and/or having union with KATHERINE A GOULD's mouth with his penis, and KEITH JERMAINE MYLES coerced KATHERINE A GOULD to submit by threatening to use force or violence likely to cause serious personal injury to KATHERINE A GOULD, and KATHERINE A GOULD reasonably believed that KEITH JERMAINE MYLES had the ability to execute the threat, contrary to Florida Statute 794.011(4)(b) and (e)2. (1 DEG FEL)

COUNT 3: KEITH JERMAINE MYLES on or about March 8, 2015, in the County of Palm Beach and State of Florida, KEITH JERMAINE MYLES, a person 18 years or older, did unlawfully commit sexual battery upon REBECCA C MCKILLEN, a person 18 years of age or older, without that person's consent, by penetrating and/or having union with REBECCA C MCKILLEN's mouth with his penis, and KEITH JERMAINE MYLES coerced REBECCA C MCKILLEN to submit by threatening to use force or violence likely to cause serious personal injury to REBECCA C MCKILLEN, and REBECCA C MCKILLEN reasonably believed that KEITH JERMAINE MYLES had the ability to execute the threat, contrary to Florida Statute 794.011(4)(b) and (e)2. (1 DEG FEL)

COUNT 4: KEITH JERMAINE MYLES on or about March 8, 2015, in the County of Palm Beach and State of Florida, did knowingly enter a structure which is a dwelling, the property of REBECCA C MCKILLEN and/or KATHERINE GOULD and/or COURTNEY MCKAY, with intent to commit an offense therein, and in the course of committing the burglary made an assault or battery upon REBECCA C MCKILLEN and/or KATHERINE GOULD and/or COURTNEY MCKAY, contrary to Florida Statute 810.02(1) and (2)(a). (1 DEG FEL, PBL)
