Dear Mr. Harris,

A response in this death penalty case is due April 25, 2019. Respondent respectfully requests a twenty-nine-day extension of the present deadline, up to and including May 24, 2019. This is Respondent's first request for an extension in this case. The extension request is not sought for an improper purpose, including harassment or unnecessary delay. Rather, the undersigned requires additional time due to the demands of a capital caseload, primarily litigation related to the then-pending execution of Patrick Murphy, *see, e.g., Murphy v. Collier*, 139 S. Ct. 1111 (2019), and briefing in another capital case before this Court, *see* Brief in Opposition, *Freeney v. Davis*, No. 18-7414 (U.S. Apr. 15, 2019). The undersigned conferred with Petitioner's counsel, Jared Tyler, who stated that he was not opposed to this requested extension. A copy of this letter will be sent to Mr. Tyler.
