

Ground-1

the State of New York Department of law, has issued a Statement on March 29 2019, contrasting with the decision of the United States District Court of Appeals about case USCA 2 N° 18-1250, and contrasting with the decision of the State of New York Supreme Court and the decision of the State of New York Court of Appeals on the same matter.

This Statement also known as the Defendant's waiver of the Right to file a Brief in opposition, was endorsed by the New York State Attorney General, and advises the United States Supreme Court, that the Defendant is withdrawing the allegations of his prosecution brought against me before the New York State Supreme Court on May 03 2016. - Indictments 203414 and 228414.
