## PRO SE REQUEST FOR APPOINTMENT OF COUNSEL AND BRIEF IN SUPPORT

Petitioner, Termane Wood, appearing pro se, respectfully moves the Court for leave to proceed *in forma pauperis* and further respectfully requests the appointment of counsel to assist in the preparation, filing, and presentation of a petition for a writ of habeas corpus pursuant to Title 28 United States Code, Section 2254.

- 1. I am in the custody of the Warden of the Oklahoma State Penitentiary in McAlester,
  Oklahoma as a result of a first degree murder conviction and sentence of death entered by
  the District Court of Oklahoma County, in Case No. CR-2002-46.
- On appeal, the Court of Criminal Appeals affirmed my conviction and death sentence on April 30, 2007. Wood v. State, 2007 OK CR 17, 158 P.3d 467, cert. denied, October 29, 2007. My Application for Post Conviction relief was denied by the Court of Criminal Appeals of the State of Oklahoma on June 30, 2010.
- I asserted a number of violations of the United States Constitution in state court
  proceedings, but the state courts did not remedy those violations. All of those claims are
  exhausted.
- 4. I am indigent.
- 5. I desire to pursue a federal habeas corpus action.

6. I request that this Court, pursuant to Title 18, United States Code, Section 3599 (e) and McFarland v. Scott, 512 U.S. 849, 114 S. Ct. 2568, 129 L. Ed.2d 666 (1994), appoint experienced capital habeas corpus attorneys to represent me in federal court and prepare a habeas corpus petition for me. See also, Chapter Six of the Guide to Judiciary Policies and Procedures; 18 U.S.C § 3006A. Specifically, I request the appointment of the Death Penalty Federal Habeas Corpus Division of the Federal Public Defender's Office for the Western District of Oklahoma (the FPD), which, I am told, serves all federal districts in Oklahoma. Alternatively, I request appointment of a lawyer from the Special Death Penalty Habeas Corpus Panel maintained by the FPD.

7. I further request that this Court stay the running of any period of limitations until counsel is appointed.

I declare, under penalty of perjury, that the facts set forth above are true and correct.
