FOR EXTENSION OF TIME TO FILE A PETITION
FOR A WRIT OF CERTIORARI TO THE
ALABAMA SUPREME COURT

To the Honorable Justice Clarence Thomas, Associate Justice of the Supreme Court of the United States and Circuit Justice for the United States Court of Appeals for the Eleventh Circuit:

Petitioner, Mr. Demetrius Frazier, by undersigned counsel, pursuant to Supreme Court Rules 13.5 and 30.2, respectfully requests that this Court grant him a forty-five (45) day extension within which to file a Petition for a Writ of Certiorari to the Alabama Supreme Court. The Federal Defender's Office will be representing

Mr. Frazier and was appointed in federal court on a pending habeas corpus petition from Mr. Frazier's state court conviction and sentence.¹

The Alabama Supreme Court denied discretionary review on November 16, 2018² rendering the petition for writ of certiorari to this Court due on or before February 14, 2019. This Court has jurisdiction pursuant to 28 U.S.C. §1257(a).

Supreme Court Rule 13.5 permits a Justice of this Court, "for good cause" to extend the time to file a petition for a writ of certiorari for a period not exceeding sixty (60) days. The application must be received by the Clerk at least ten (10) days before the petition is due, except in extraordinary circumstances.³ This request for an extension of time is being filed through the Court's electronic filing system sixteen (16) days before the petition is due.

Undersigned counsel believes that there is good cause to justify the requested extension of time. Undersigned counsel currently represents a number of Alabama inmates under a sentence of death. These clients have cases pending in the Eleventh Circuit and the United States District Courts for the Middle District of Alabama, Northern District of Alabama, and Southern District of Alabama. Counsel currently has pleading deadlines on February 6, 2019, February 14, 2019, February 22, 2019, and March 15, 2019. Moreover, a client of one undersigned counsel has an execution date set for February 7, 2019. Due to the convergence and proximity of

the filing deadlines in multiple cases, undersigned counsel needs additional time to research and prepare a petition for a writ of certiorari in this case.

Petitioner respectfully requests that an order be entered extending his time to petition for certiorari by forty-five (45) days, up to and including March 31, 2019.
