Dear Mr. Harris:

I represent the respondent, Robert Neuschmid, Acting Warden, in the above-entitled case. The petition for writ of certiorari was filed on March 29, 2019. On May 21, 2019, this Court requested a response. The brief in opposition to the petition is currently due on June 20, 2019. I respectfully request that the time for filing that brief be extended to Monday, July 22, 2019, (thirty days from June 20, 2019, is Saturday, July 20, 2019). I have not previously requested an extension to file the brief in opposition.

I am requesting additional time because, when this Court ordered a response to the petition on May 21, 2019, my attention was directed to completing responses in the previously assigned matters of *Pappas v. Miller*, EDCV 14-1994 CJC (SS), Proposal for Compliance with Remand filed on May 22, 2019; *Williams v. Paramo*, EDCV 17-01974-JGB (SHK), merits Answer filed on May 30, 2019; and *Hultman v. Paramo*; ED CV 18-1439-CJC (PLA), merits Answer due June 12, 2019.

Furthermore, I will be out of the office June 4, 2019 through June 11, 2019. Upon my return, I will turn my attention to the above-entitled case.

Additionally, the filing of the brief in opposition will require an extensive review process in consultation with the Solicitor General of California. This process cannot be completed without the requested extension of time.
