Petitioner, ANTYANE ROBINSON, through counsel, respectfully asks for leave to file the attached Petition for Writ of Certiorari without prepayment of costs and to proceed *in forma pauperis*. In support of this application submits as follows.

Petitioner is a prisoner in the custody of the Pennsylvania Department of Corrections. He has previously been granted leave to proceed *in forma pauperis* in the Court of Common Pleas of Cumberland County; the Supreme Court of Pennsylvania; the United States District Court for the Middle District of Pennsylvania; and the United States Court of Appeal for the Third Circuit.

Petitioner's affidavit or declaration is not attached because the Cumberland County Court of Common Pleas appointed undersigned counsel to represent


Petitioner on January 21, 2015 and the appointment continued through the proceedings in this matter in the courts below.
