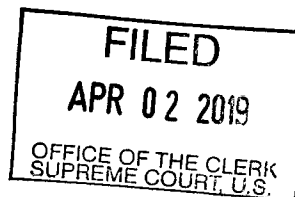

- c) Fourth Circuit Court of Appeals

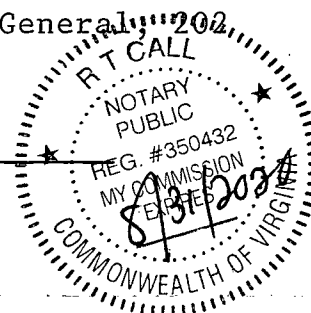
