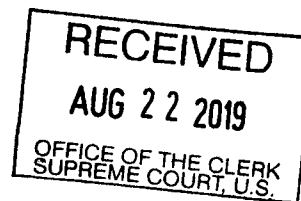

**PETITION FOR REHEARING**

Pursuant to Rule 44 of this Court, the acting Solicitor General, on behalf of the United States and the others petitioners, hereby respectfully petitions for rehearing of this case before a full nine- Member Court.

1. A certificate stating that the grounds are limited to intervening circumstances of substantial or controlling effect or to other substantial grounds not previously presented. This case involves a challenge by the Respondents states a form notifying opposing counsel that the case was docketed on April 23, 2019 and filed on February 22, 2019 as No. 18-8945, from the Supreme Court OFFICE CLERK. Scott S. Harris by Susan Frimpong, case analyst. NOTICE GIVEN by Supreme Court to Respondent's Life Unlimited Inc. and Department of Mental Health and counsel for Respondent's on April 23, 2019. Respondent's Due date due for brief in opposition due on May 23, 2019.

Respondent's and attorney's have broken laws failing to acknowledge, answer, admit or resolve this case with Race Discrimination proven misconduct, workplace discrimination, disability violations, civil and constitutional violations, 1<sup>st</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 14<sup>th</sup> AMENDMENT violations and no courts to pursuant to rule 44, while working Pro Se with conflicts, all exhibits and documents submitted. Where is the justice and honor in this

court system, Petitioner is Denied by the courts and unable to receive help with a Professional Attorney, while Petitioner name is blackballed on wrongful false allegations, unable to work and survive this is slavery clearly, Petitioner name is held hostage with no due process laws followed by Respondent's or the courts, fighting for my rights seeking justice in this cruel racist unfair corrupt system. PETITIONER FILES for Oral Argument and Objection's to all denials for rehearing in my case, notice June 24, 2019. The Petition for writ of certiorari is denied while working PRO SE, in extraordinary circumstances, relief requested is appropriate in courts with all costs, interest, and damages for delay that may be awarded, request Rule 22; Application to Individual Justices to grant relief for all treaties, statutes, ordinances, and regulations violations.

2. Petitioner is Fighting for justice, due process laws are violated, while Petitioner is requesting a response while, rights and name are held hostage unlawful on a registry list, by Respondent's listed, blocked from seeking employment or income to survive like all citizens, this is against the law, by Respondent's Life unlimited Inc. and Department of Mental Health government agency, while court documents state Petitioner is NOT GUILTY; MUNICIPAL COURT TRIAL FINDINGS of all charges. Petitioner conflicts are not resolved by federal court, appeals court or supreme courts, Respondent's are unlawful seeking Stays; Rule 23 enforcement of judgment and relief; See 28 U.S.C. 2101(f).

this case while being overlooked by the courts which have the power to intervene and enforce and demand actions, Notice and Comment Rulemaking Procedures TAKE CARE OF THE CONSTITUTION. 3. This court therefore should grant Rehearing to provide for a decision by an equally divided Court to leave in place a nationwide injunction of such significance. See Home Ins. Co. v. New York, 122 U.S. 636(1887)(GRANTING REHEARING February 7, 1887, and 134 U.S. 594(1890) REARGUMENT March 18-19, 1890);Selma, Rome & Dalton R.R v. United States,122 U.S.636(1887)(GRANTING REHEARING.

### **Conclusion**

For the foregoing reasons, the petition for rehearing should be granted.
