PLEAS AND JUDGMENTS

BE IT REMEMBERED, that on the 30th day of November, 1982, the same being a day of the regular September 1982 Term of the Pulaski Circuit Court, First Division, before the Honorable Floyd J. Lofton, Judge of said Court, this cause came on to be heard, the State being represented by the Honorable Lloyd King, Deputy Prosecuting Attorney, the defendant being represented by the Honorable Ron Heller, and all parties announcing ready, thereupon, the following proceedings were had and done, as follows:

MRS. JERNIGAN, DEPUTY CLERK:

Larry Crutchfield and Terrance Proctor,

CR 82-1262.

THE COURT:

All right. This is Terrance Proctor and Crutchfield. Right?

MR. JACKSON JONES, COUNSEL FOR CRUTCHFIELD:

We have the correct Crutchfield this time.

THE COURT:

Larry.

All right. State of Arkansas versus
Terrance Proctor, 82-1262, robbery. Ron Heller represents
him. And Larry Crutchfield, robbery. And the Public
Defender represents him.

I've been handed a plea statement.

Mr. King represents the State.

Have you all reached an agreement?

MR. JONES:

No, we have not, your Honor.

THE COURT:

It's a plea to the Court?

MR. JONES:

Yes, sir.

MR. HELLER:

Yes, your Honor.

THE COURT:

Both of these young men are going to
plead guilty to robbery?

MR. JONES:

Yes, sir.

MR. HELLER:

Yes, sir.

THE COURT:

You understand the Court could sentence you from five to twenty years and a Fifteen Thousand Dollar fine?

BOTH DEFENDANTS:

Yes, sir.

THE COURT:

Has anybody promised you anything or any leniency?

BOTH DEFENDANTS:

No, sir.

THE COURT:

Or threatened you with anything?

BOTH DEFENDANTS:

No, sir.

THE COURT:

You're pleading guilty freely and voluntarily?

BOTH DEFENDANTS:

Yes, sir.

THE COURT:

What are the facts, Mr. Prosecutor?

MR. KING:

Your Honor, on July the 22nd of 1982, Mrs. Barbara Brown and her daughter, Gail Swan, who are present in Chambers at this time, were shopping together at Park Plaza. As the two ladies left an area of Dillards going

to their respective cars, a car driven by Mr. Proctor came around the corner. Mr. Crutchfield got out of the car, ran up behind Mrs. Brown, grabbed her around the neck, then grabbed her purse. At that time, either hit or kicked her as she had pulled away from him, resisting it. At that time he got the purse away from her, got in the car and fled from the scene. Bystanders noted the license tag of the car and the make of the car and it came back registered to Davis Proctor, who apparently is a relative of Defendant Proctor.

The next day at approximately 9 a.m. Terry Proctor was arrested and transported to the Little Rock Police Department, whereupon he gave a statement admitting to being the getaway driver with Mr. Crutchfield during the robbery. A warrant was issued for Mr. Crutchfield's arrest. He was later arrested and ultimately gave a statement admitting to the pursesnatching/robbery of Mrs. Brown. As a result of the actions of Mr. Crutchfield, Mrs. Brown was bruised in the neck area, had a sore neck. She also stated that she had soreness in her chest and back and had bruises on her leg.

As I understand it, the purse was never recovered.

THE COURT:

Mr. Proctor, Mr. Crutchfield, you heard

the statements of Mr. King. Are those true and correct?

Is that true and correct?

DEFENDANT CRUTCHFIELD:

Everything is true but I did not kick
her or hit her.

DEFENDANT PROCTOR:

Well, I don't know if he hit her or
kicked her or not. The other statement is true but
I ain't seen him hit her.

THE COURT:

You did snatch the purse?

DEFENDANT CRUTCHFIELD:

Yes, sir.

THE COURT:

Did you apply some force to her?

DEFENDANT CRUTCHFIELD:

No, sir. Her hands was full, sir.

THE COURT:

How did you get the purse from her?

DEFENDANT CRUTCHFIELD:

I just snatched it. I did not hit her.

I didn't even put my hand on her.

THE COURT:

What did he say in his confession?

MR. KING:

Talking to the victim, she said I did misstate her injuries slightly. She had soreness in the neck and soreness in the chest. There were no bruises on her neck. The bruises were on her legs.

THE COURT:

Mrs. Brown, did he strike you?

Did he strike you?

MRS. BROWN:

Something occurred during all of this.

It happened so fast I can't say exactly what did happen.

THE COURT:

But, as a result of him snatching your purse from you, you were injured?

MRS. BROWN:

Bruised, yes.

THE COURT:

And you agree that in the process of snatching the purse from her she could have sustained some injuries?

DEFENDANT CRUTCHFIELD:

She couldn't have.

MR. KING:

Here's his statement. He says, "I let her get halfway across the lot and then ran up and grabbed her pocketbook. I then ran to the car and jumped in

and a man started chasing us."

THE COURT:

What does it require? Some physical --

MR. KING:

It requires employment of physical force.

Was your purse on a strap around your shoulder at that time?

MRS. BROWN:

No. It was one like this.

MR. KING:

Also, your Honor, the victim's daughter was present at the time and she observed what happened.

THE COURT:

What did you see? Maybe you weren't as preoccupied or as scared as your mother was.

MRS. SWAN:

The first thing that my mother said to me when I got back -- When I realized what was happening, I tried to get the purse back by chasing him. And the first thing she came up to me saying -- After he got away, she was screaming and she said, "Did you see what he did?" And I said, "No." And she said, "He grabbed me by my neck. He was trying to choke me."

MR. KING:

Did you see that yourself?

MRS. SWAN:

No. When I turned around, he was up underneath and it looked like he had his hand on her and he was trying to get her off balance, yanking that purse.

THE COURT:

What do you mean "up underneath her"?

MRS. SWAN:

Somewhere around her body.

THE COURT:

Okay. It says, "He employs or threatens to immediately employ physical force upon another." And there are some cases that say that the physical force applied as a result of snatching a purse from someone is insufficient physical force to sustain the conviction for robbery. Now, whether that's the law this week or not, I don't know.

And you say you didn't use any physical force at all?

DEFENDANT CRUTCHFIELD:

No, sir.

THE COURT:

Didn't threaten her to use any physical force?

DEFENDANT CRUTCHFIELD:

No, sir.

THE COURT:

What do you want to do, folks?

MR. KING:

Your Honor, I think from her description of resisting him I think it's ludicrous for him to assert that she just handed the purse over to him. There had to be more involved than what he's saying.

THE COURT:

Well, I can understand that but I think the law is, Lloyd, that even if she resisted the removal of the purse, that just the physical force necessary to extract the purse from her, unless there was a strap around her neck or shoulder which caused her to fall down or something -- That kind of force is required. Just removing the purse from under her arm or something like that is not sufficient force.

MR. JONES:

Your Honor, a defendant doesn't have to admit every element of the offense. If the Court can find factual basis for the offense from other sources, then it's possible for the Court to accept the defendant's plea.

THE COURT:

Well, there's no question in my mind

that I can say from what Mrs. Brown tells me that she suffered some injuries, some bruises and what have you. And her daughter there says that he grabbed her around the neck. Now, if he tells me that he may have done that in this excitement, I can find from the evidence. Or, if he says, "I don't remember doing it. I didn't think I applied any force", I can find, if he's not going to object, and accept his plea. I can find that he did that. But, if he stands up here and says, "Judge, I don't care. I didn't do that", then I'm going to be hard pressed to do it.

MR. HELLER:

We may have, your Honor, a situation here -- From viewing the Prosecutor's file, I didn't realize, of course, that there was a question about physical force in this case. It now appears -- My client was the driver of the car. It now appears we may have instead of a robbery case a theft case.

THE COURT:

Well, there's no question about it. You can convert to a theft and the penalty will be -- It's five to twenty now. It would be what? Four to ten?

MR. JONES:

To ten.

MR. KING:

If we're going to convert to a theft,
I think I'd rather let the jury do that than me. If
they think all they did was pursesnatching, not robbery,
then they can show that to the jury.

MR. HELLER:

Well, your Honor, I think my situation
may be somewhat different than Mr. Crutchfield's. As
the Court's aware, there's an additional number of felonies
that are pending.

THE COURT:

Is this the guy that's got nineteen
of them pending?

MR. HELLER:

That's correct.

THE COURT:

Well, it doesn't make much difference
what we take in the case.

MR. HELLER:

Well, it does, though, somewhat, your
Honor.

You know, to protect the record for
my client, I think it's important.

THE COURT:

Okay. Well, I imagine the Prosecutor
would let him plead guilty to a theft of property at

some point in time.

MR. KING:

Right.

MR. HELLER:

Okay. I'm not sure what's happening now. Are we just not going to enter a plea today?

THE COURT:

I don't know.

What are you going to do, Jack?

Is your man willing to admit he used some force?

DEFENDANT CRUTCHFIELD:

Your Honor, well, I --

THE COURT:

Don't talk to me. Talk to your lawyer.

MR. HELLER:

I would be willing in my situation, your Honor, to enter a plea in this case until all the other nineteen felonies are up here and then present ourselves to the Court at that time, once I got a chance to review the file on those nineteen so we can see what we've got.

As the Court's aware, I'm in a position I don't know what to do with my client until those other cases are before it. If that's okay with the Court.

MR. JONES:

Your Honor, Mr. Crutchfield states that he did see the lady fall down.

THE COURT:

As a result of his snatching the purse from her?

MR. JONES:

That's my understanding.

THE COURT:

Is that right?

DEFENDANT CRUTCHFIELD:

Yes, sir.

THE COURT:

He says he saw the lady fall down as a result of the force that he used in snatching the purse from her.

MR. KING:

Okay.

THE COURT:

Mr. Proctor, you knew that Mr. Crutchfield was going to go steal that purse, didn't you?

DEFENDANT PROCTOR:

Yes, sir.

THE COURT:

And you were driving the car?

DEFENDANT PROCTOR:

Yes, sir.

THE COURT:

And you knew that if he had to apply some force on that woman, twist her arm or break the strap if it was around her arm or whatever, he'd do that, he'd jerk it off or yank it off with whatever force was necessary to get the purse, didn't you?

DEFENDANT PROCTOR:

Yes, sir.

THE COURT:

Are you pleading guilty to robbery because you are guilty?

DEFENDANT PROCTOR:

Yes, sir.

THE COURT:

Mr. Crutchfield, are you pleading guilty to robbery because you are guilty?

Have any threats or promises been made to cause you to enter this plea?

On the day in question, you did have
a weapon and you did display it?

THE DEFENDANT:

Yes, sir.

THE COURT:

And you threatened to use it and you
took their property?

THE DEFENDANT:

Yes, sir.

You're pleading guilty because you are
guilty?

THE DEFENDANT:

Yes, sir.

THE COURT:

All right. The plea of guilty is entered
and accepted. The Court finds that the offense was committed
essentially as alleged in the information. The Court
finds that the defendant committed the offense essentially

plea of guilty is freely and voluntarily entered and

He discussed what the State would have

to prove in each case and what possible defenses you might have?

Are you satisfied that if the State went to trial in each case, in each count, that they could prove you guilty?

Yes, sir.

THE COURT:

And you and Mr. Heller have discussed any possible defense that you might have to each count and you've decided that the State could prove it and that you are guilty and that you would plead guilty?

Do you understand also that you could get, I guess, ten life sentences, consecutive, one to the other?

Has anybody promised you anything about
what I'll do?

No.

And you're doing this freely and voluntarily?

THE DEFENDANT:

Yes.

And the Court has continued this so that we could do this all at one time. And the Court finds that the plea of guilty was freely and voluntarily entered and knowingly entered upon the advice of counsel and without threat or promise or intimidation, in any way coercion, and they are accepted.

Now, then, Mrs. Proctor, what do you want to say?

DEFENDANT'S MOTHER:

I just wanted to address the Court.

we've had a lot of problems. He's had a lot of drug problems and he was under some psychiatric care for a while. He was an abused child also. His father was not in the home. And, on occasions, when he tried to stay with his father, it didn't work. He only abused him. And I'm the only support that's in the home and I have one other child. And I just ask that the Court take these things under consideration.

MR. HELLER:

I think Mr. Proctor himself wanted to address the Court, also, your Honor.

THE COURT:

All right, Mr. Proctor.

MR. HELLER:

I can add a little bit of credence to that, your Honor. All these counts we've discussed today basically occurred within about a ten day period of time.

I'd ask the Court to take into consideration, of course, the statements of Mrs. Proctor and Terry and also the fact that Terry is seventeen years of age. I've stated these things. I don't intend to belittle any of these charges. I'm certainly aware and so is Mr. Proctor and his mother about the seriousness of these charges.

But I would ask the Court to take all these things in consideration in the sentencing.

MR. KING:

Judge, I think anything I said really would belittle the significance of these cases. In a period of eighteen days, he committed ten aggravated robberies, shot at a man and tried to kill him. And this was after he had been arrested on the first case

he pled to. He had been arrested, made bond and got out and started in on all these cases.

MR. HELLER:

Should the Court consider passing sentencing for a short period of time, it's possible that we could obtain some records to reflect the psychiatric care he received. I was unaware of that until this morning.

THE COURT:

You understand what's going on, don't you, Mr. Proctor?

THE DEFENDANT:

Yes, sir.

THE COURT:

You're not insane, are you?

THE DEFENDANT:

No, sir.

THE COURT:

And you understand that you've entered these pleas and you understand the elements in each case and you're not pleading that you are not competent to enter this plea, are you?

If that's the trouble, we'll all get on dope and we'll all go out and do whatever we want to. And I just can't. So, I'm going to punish this man and I'm going to send a message to other dope addicts who have got pistols. Don't do it, cause it's not an excuse.

Ron, if they break into your house and kill your wife and your new son and he says, "But I was

under the influence of drugs", you don't care and I don't care. He's the only one that cares. But we can't permit that in this society. It's just not a defense.

I am empathetic with him and I think you know me well enough to know that almost anybody that's got any kind of a reasonable chance and wants to go out to the GYST House and that rehabilitation program out there or any of the rehabilitation programs I am very much impressed with these things. And, as long as somebody can show that they're trying to get hold of it, fine. But he has not done that. He couldn't go any way. With ten robberies, he couldn't go out there.

But I can't excuse this and I'm not going to. I say I'm not going to ruin him. I am. I'm going to ruin him. I don't have any choice in the matter, whether it's ten life sentences or four hundred years. Which is the better? That's where I am. Ten life sentences or four hundred years?

MR. HELLER:

Would the Court consider running those sentences concurrent?

THE COURT:

Oh, no. Now, four hundred years would have to be ten forty year sentences.

MR. HELLER:

I understand that.

THE COURT:

The Court has said it doesn't make any difference. If it's a life sentence, it's a life sentence. But we all know that's not so. They're all commuted. If I were going to be on the Bench then, then I could look at it this way and say, "Well, I could do a life sentence on all of these and in fourteen years when he applies object to it because he's got ten of them." But I won't be here then. So, I'm looking at some period of time that --

All right. Anything else?

MR. HELLER:

We have nothing further at this time,
your Honor.

THE COURT:

How long has he been in jail?

THE DEFENDANT:

The 16th of November.

THE COURT:

In 82-1262, twenty years in the ADC.

Credit for jail time since 11/16/82.

MR. HELLER:

That's the first robbery?

THE COURT:

Yes. That's just robbery, not aggravated robbery. Right?

MR. HELLER:

That's correct, your Honor.

THE COURT:

All right, Mr. Proctor, stand up.

Mr. Proctor, it is the judgment and sentence of this Court that you be taken by the Sheriff of Pulaski County and delivered to the Department of Correction, there to serve at hard labor for a period of life in 83-74, aggravated robbery and attempt to commit capital murder.

In 82-1262, it is the judgment and sentence of this Court that you be taken by the Sheriff of Pulaski County and delivered to the Department of Correction to serve at hard labor for a period of twenty years. That sentence shall be consecutive to your life.

In 83-76, twenty years. That shall be consecutive to the life and consecutive to the other.

In 83-75, twenty years on each count, consecutive with each other and consecutive with all other sentences.

In 83-72, a term of twenty years. This

shall be consecutive with all the other sentences and consecutive to the life.

In 83-71, a term of twenty years, consecutive.

83-70, a term of twenty years, consecutive.

83-69, a term of twenty years, consecutive.

83-73, a term of twenty years, consecutive.

What I have done, Mr. Proctor, it is my intention that when you get out of the penitentiary you will be an old man. The life sentence will be the life sentence. It won't matter. I don't know how long you'll be there. But I have given you roughly a hundred and eighty years to start serving after -- or a hundred and eighty years consecutive. Now, they will run with the life probably. But a hundred and eighty years is what you are going to have to do, the way I calculate this. And my intention is to keep you there for most of the rest of your life and the only chance you have of getting out is when you're an old man.

It is the further order of the Court that in the twenty year sentences you will be entitled to whatever jail time since November the 16th, 1982. The question of jail time in 83-74, life sentence, the Court has said life is life and jail time is irrelevant and immaterial. So, it won't make any difference.

Young man, it does not do me any -- I

don't like to do this but I don't have any choice in the matter. It would be my hope that you could go down there and find you a place to live the rest of your life and by the time you're sixty-five or so get out and have some life before you die in the free world. But I don't have any choice in that. I don't have anything to do do with it.

And the only thing I can do is to look at -- It is my duty to protect us from you and the only way I can do that is what I've done.

Good luck to you.

Sheriff, he belongs to you.
