I have been assigned the responsibility of representing Respondent Brian Foster in the above-referenced matter. Pursuant to Rule 30.4, Respondent respectfully requests an extension of 31 days in which to file its Brief in Opposition to the above-referenced Petition. The brief is currently due May 24, 2019. Granting this extension would make the brief due June 24, 2019.

Therefore, the Respondent requests an extension of time in which to file its Brief in Opposition to ensure that I have time to provide the Court with a thorough and responsive brief.

Counsel for the Respondent has contacted the current counsel of record for Petitioner Scott E. Schmidt, who consents to the proposed extension of briefing.
