**MOTION FOR EXTENSION OF TIME UNTIL MARCH 25, 2019**

Bruce Wayne Harrison seeks until March 25, 2019 to submit his petition for writ of certiorari. Mr. Harrison is currently incarcerated at Coleman (low) and the normally adverse conditions for pro se litigation have been made worse by the government shutdown.

Normally, the Coleman prison complex which houses between 1,850 and 2,000 prisoners (maximum capacity 1,520) allows unrestricted access to the twelve law-library terminals and one photocopier for between 10 and 13 hours per week. The shutdown has reduced that to less than 8. Access to the mailroom and commissary (stamps, writing supplies, copy cards that are only available 75% of the time, etcetera) is normally 6 hours per week, now 4. In order to type the pleadings, inmates typically have to share 6 non-memory typewriters which are available for general population's unrestricted use 10 to 13 hours per week, but now are available less than 8.

Summarizing the Coleman low prison has too many prisoners and not enough equipment. Thus, it is very hard to properly research and prepare legal work under normal conditions, and the shutdown has made it worse.

Adding gasoline to this fire, the shutdown crushes the already low morale among the staff. And the one trained law clerk in the library only works two and a half hours per week.

The upshot, Mr. Harrison needs an extended period of time to properly prepare his pleadings. A time period which is not prejudicial to the government since Mr. Harrison is currently serving his sentence and no evidence is spoiling or wasting.


