**Application to Extend the Time to file a Petition for a Writ of Certiorari from
May 8, 2018 to July 6, 2018**

1. Final Order was issued by United States District Court Tenth Circuit on February 7, 2018.
2. Said order is a worthy of review by the Supreme Court of the United States as the interpretation and application of "Withdrawal of Reference," from the Bankruptcy Court to the U.S. District Court has created multiple circuit court splits and confusion, with regard to Federal Bankruptcy code and rulings.

3. Said order allows the separation of powers to be violated, allows conflicts of interest in the Bankruptcy Court to be ignored, and the ability for a debtor to seek justice regarding foundational reviews of jurisdiction, when aforementioned conflicts exist.
4. The ninety (90) days for ***Petition for a Writ of Certiorari*** from February 7, 2018 would be May 7, 2017. *See* Supreme Court Rule 13.1.
5. It has been less than 90 days since the entry of said order. *See* Supreme Court Rule 13.1.
6. Due to the nature breadth and depth of the issues affected by said and resulting appeal, and the far reaching unintended consequences, of the Ruling being appealed, petitioner, currently *pro se*, respectfully requests additional time to prepare and file a ***Petition for a Writ of Certiorari*** with the Supreme Court of the United States, as is permitted and appropriate. *See* Supreme Court Rules 13.1 and 13.5.
7. Petitioner respectfully requests of this Court, an extension of sixty (60) days to file a ***Petition for a Writ of Certiorari***, and ask for permission to file by **Friday, July 6, 2018** (sixty day extension from May 7, 2018). *See* Supreme Court Rule 13.1 and 13.5.
8. This **application to extend the time** is appropriate and reasonable, and should be **GRANTED**.
