The Clerk of this Court saw that the petitioner had failed to put a motion of certification(Please see the inclosed motios)

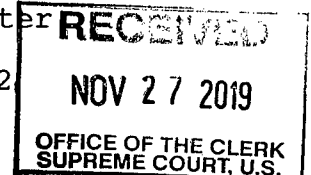


