Petition for Enlargement of Time
To File Writ of Certiorai
Jurisdiction

The Dicision by The United States Court of Appeals For The
Fourth Circuit Entered a Per Curiam Opinion Denying the Petitioner's
Appeal of His Conviction and Sentence in The Middle District of
North Carolina.

Consequently Petitioner Files the Instant Application for a
Writ of Certiorai under the authority of 28 U.S.C. § 1254(1).

Comes now the Petitioner Willie Anthony Saxby Jr. Pro Se, to
respectfully request, pursuant to rule 30 of the Rules Of The
Supreme Court of the United States, an extension of the deadline of
March 27th, 2019. For the filing of the Petition for Writ of
Certiorai until May 27th, 2019.

As Gounnds for this Motion, Petitioner respectfully advises
the Court that a Sixty (60), day Enlargement of Time will provide
Petitioner the needed opportunity to perform the required research
necessary to suport his position.

This request is not interposed for dilatory purposes, and will

not prejudice the parties in the Case. This is the first such extension requested by Petitioner Saxby, acting in a Pro-Se Capicity, who is presently incarcerated in FCI Beckley, Po Box 350, Beaver,WV 25813. In Further Support of this request, Saxby submits the following information to this Honorable Court.

Grounds

(1) Saxby is a Federally Incarcerated Inmate at FCI Beckley, Beaver, West Virginia, where there is no Legal Assistance Program, or B.O.P. Staff trained in legal matters in which to assist Prisoners at this Institution in legal matters, and Inmate access to current updated legal cases has been suspended by the B.O.P. Due to the cancelation of a weekly Posting of the Criminal Law Reporter, (CLR), and the cancelation of the Replacement Site Providing Inmates with aces to current updated Legal Rulings of The United States Supreme Court, and other Judicial Districts.


(2) This Federal Institution is subject to periodic, "lock downs." Which limits access to the Law Library substantially, Due to inclement weather such as fog, Staff Training, Institutional Implemented Holidays, inmate disturbances, Government Shut Downs, etc., That result in the closing of the law library. Moreover, the law library, when in operation, is availabe to no more than ten, (10) Ten Inmates at a time on a compound of naer 1,500; and dictated by a split leisure/recreational move, between the hours of 6:30-8:30PM Monday-Thursday, during which Inmates only have access to Ten (10) typewriters at any given time to facilitate legal work.

(3) Inmate Legal Mail is unduly delayed before being given to us, under the premise of inspection for controled substances, which

causes Legal Mail to be severly delayed, sometime for over a period of two (2) weeks, even if it is addressed from The United States District Courts, or The Supreme Court.

Wherefore upon these reasons contained herein, Petitioner Saxby, Pro-Se, respectfully moves this Honorable Court to Grant Petitioner the requested sixty (60) day enlargement of time that will better enable him to present all viable issues in a significant and meaningful manner.
