PETITION FOR REHEARING

NOW INTO COURT, comes Plaintiff/Petitioner, Clifford C. Abshire, III, who respectfully submits, pursuant to Rule 44 of the Rules of this Court, for consideration of this request for rehearing:

1.

As previously relayed by the Office of the Clerk of this Court, the Petitioner's previous request for rehearing was postmarked October 31, 2019, and was received November 7, 2019. Due to failure to comply with Rule 44 of the Rules of this Court, the request was returned and the Petitioner was granted fifteen (15) days to correct his request and present it to the Court. See, Rule 44.6 of the Rules of this Court. This timely corrected request follows.

The reason and cause for this request for rehearing set upon these premises: (1) The decisions of the nations district, appellate and supreme courts conflict with the law and jurisprudence of the decisions of the courts which have reviewed the facts of this case; (2) Obvious conflicts with the law and jurisprudence of several inferior United States District Courts that hold that the Petitioner entitled to the relief desired; (3) The controlling precedent, *Sandin v Conner*, should be overruled or substantially modified; and (4) There is an erroneous interpretation and/or application of the constitution, law and jurisprudence of the United States

and the State of Louisiana.

Moreover, there is a substantial need for the granting of writs in this matter.

The Petitioner further certifies that this petition for rehearing is presented in good faith and is not for delay.

WHEREFORE, the Petitioner prays that the Court will consider the premises presented herein, and grant his writ application, thereby remanding the matter to the district court for the purposes of addressing the claims set forth in his *Petition for Judicial Review*.
