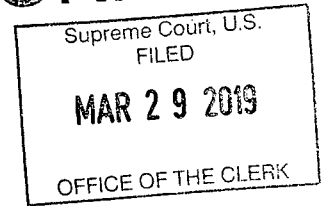

Answer to Question #12

WHY I CANNOT PAY THE COSTS OF THIS CASE

JAMES C. CAMPBELL CLERK OF COURT (Clerk)--on seven different occasions-- has not and will not file my in forma pauperis Motions with the Court inducing me not to present my case and depriving me of the opportunity to be heard and depriving my access to the court, deeming me unable to move forward with litigation, preventing my access to my assets (money). To my surprise, my wife (Sharon) had filed for a divorce, and which Judgment of such divorce is void due to jurisdictional Issue(s). I became misconvicted when Sharons teenage grand-daughter (Marian) made false truths at trial and I can prove it because in that video of Marian, Marian said I did not do those things she said I did at trial, Trial Court inappropriately did not allow that video evidence to be seen or heard by the Jury and I was not permitted to see or hear that video evidence until after I got to prison. I was unaware the counsel I had at trial was Marians friend and friend of her family which he admitted at the second trial and that is in the transcript, but the words I spoke at the two trials were not in the transcripts and the State never corrected those transcripts or addressed those issues even though I complained.

Sharon and I had gained custody of Marian, Marian's mother Angie then restored relations with Sharon from where years prior Angie gave into 'crack' Cocaine addiction and prostitution of herself for her addiction therefore betraying Sharons sons marriage. Angie wanted custody of Marian and she got it at my expense; my conviction because of Marians false truths.

Sharon, my wife of many years, without my knowledge had planned divorce and obtained counsel before we gained custody and has since divorced me using three different attorneys and since I had been thrown in jail, I have not been permitted access to my money or property to hire any lawyers to defend myself and I have not been able to access any of my money or property since my surprise incarceration. Sharon has since declared 'Chapter 7' Bankruptcy on the last piece of real estate with my name on it, Sharon

has concealed, destroyed, mutilated, falsified and failed to keep or preserve recorded information from which Sharon's financial condition or business transactions might be ascertained notwithstanding my requests from Sharon for the same. Sharon has defrauded me of my property. Sharon has committed actual and constructive fraud upon me. Sharon sold two of our business properties for two-hundred-thirty-thousand dollars (\$230,000.00) each where I am denied from accessing any money because of Ex Parte Court Order freezing my assets not related to my misconviction. Clerk has a lawsuit against it by me where it violated my constitutional rights by not filing my in forma pauperis Motions I sent to it for the Court seven different times denying my access to Court preventing my Motions from being heard, and so I may access my money. That Clerk is affiliated with my misconviction and the inappropriate government interference by the incursion of pretrial freezing of my legitimate untainted assets as a criminal defendant (see attached ORDER FOR EX PARTE / EMERGENCY HEARING). That Clerk has committed extrinsic fraud upon me, and that Clerk has refused to file my Application for Post-Conviction Relief Motion with the Court. I am not an attorney. I am not one who is experienced in dealing with legal matters. I have been inappropriately forced to be an indigent prisoner by operation of the government and I am faced with having to present papers with many courts regarding my self and my property. I cannot properly read law. I cannot properly read Court orders. I am trying my best to frame the issues involved in the matters of this and the many cases where they and all of the information surrounding them are intricately intertwined. I am forced to be an unrepresented person who cannot afford counsel and I am forced to be pro se all because officer(s) of the Court actions have effected my poverty. That is why I cannot pay the costs of this case. In support of my claims I declare under penalty of perjury the foregoing is true and correct.

**ORDER FOR  
EX PARTE / EMERGENCY HEARING**

Based upon a review of the Complaint and supporting Affidavit of the Plaintiff, it is apparent that there is a need for an emergency hearing as this involves the parties' assets and debts. Due to the severity of the criminal charges and the multiple counts of each charge, there is a necessity of a Restraining Order against the Defendant from disposing of any assets currently in his control, possession or name, in with the Plaintiff may have equitable interest, or from further incurring any debts in the Plaintiff's name or for which the Plaintiff is responsible.
