Respondent Palm Beach Park Association¹ respectfully requests an extension of time of thirty days to file its brief in opposition to Petitioners' Petition for a Writ of Certiorari, which was filed in this Court on June 11, 2019. Respondent's opposition

brief is currently due on July 15, 2019. Respondent requests a thirty-day extension to August 14, 2019.

On June 11, 2019, Petitioners Floyd M. Chodosh, Sue Eicherly and Ole Haugen filed a Petition for a Writ of Certiorari together with appendices containing 98 pages. I have completed a draft of the brief in opposition, and while it was my intention to file the brief by the due date of July 15, 2019, I have encountered some unexpected medical issues that have delayed completion of the final version of the brief in opposition. On June 28, 2019, I was diagnosed with bladder cancer, which required unplanned time out of the office since the diagnosis. I also have exploratory surgery scheduled for July 12, 2019, and I am uncertain as to when I can resume normal business activities following the surgery.

Further, I have three additional appellate briefs due on July 15, 2019, including an opening brief in a preference case, *Badgarsarian v. Skillserve, Inc.* (Los Angeles County Superior Court Case No. 19LBCV00238); an amicus brief in *Busker v. Wabtec* (Cal. Supreme Court No. S251135); and a respondent's brief in *Pollock v. Kelso* (Cal. Court of Appeal No. B294872). In addition, I have a respondent's brief due in *Harris, et al. v. University Village* (Cal. Court of Appeal No. B293290) on July 18, 2019, and a respondent's brief due in *Robertson v. Peyman* (Cal. Court of Appeal No. B292448) on July 18, 2019.
