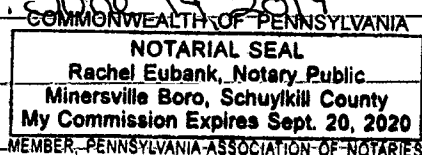
(7.) The aforementioned statements are true and correct and have been provided under my own volition.
