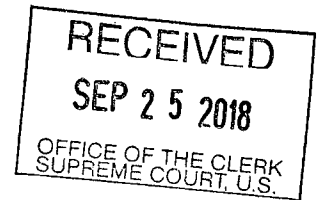

Honorable Justice Ginsburg:

I am applying to the Court for the grant of a 60-day extension, from October 17, 2018 to December 16, 2018, so I may timely file a petition for writ of certiorari.

Enclosed with this application, is the final decision of the Second Circuit Court of Appeals dated July 19, 2018.

I am asking for an extension of time of the October 17 deadline as I am unable to file the petition by the October 17, 2018 deadline, because of my schedule and as a sabbath observer I have been limited due to the Jewish holidays. The Jewish holidays started September 9, 2018 and last through October 2, 2018. From September 9, through September 11 was Rosh Hashana (Jewish New Year), the Jewish new year. September 12 was a fast day (Fast of Gedalia). From September 18 through the 19th

was Yom Kippur (Day of Atonement). From the eve of September 23 through October 2, are the holidays of Sukkot (Feast of Tents), Chol Hamoed (Feast of Tabernacles), and Simchas Torah (the Feast of Rejoicing the Torah). Each of these holidays prohibit me, an observant Jew from engaging in writing and doing regular work. In observance of these holidays, neither my appellate printer nor I will be able to timely file the petition.

In addition, from October 3 2018 through October 15 2018, in the State of New York, I am scheduled to appear in multiple neck to neck court appearances in several courts, in which I am to appear as the attorney for parties, including two criminal matters in which I am actually engaged. On October 3, 2018, I am actually engaged in the matter of the People of the State of New York v. Jason Hall, in the Kings County, Supreme Court, Criminal Term, and on October 10, 2018 I am actually engaged, pro-bono, in the matter of the People of the State of New York v. Usher Benzeev, in the Supreme Court, Criminal Term.

I respectfully request that the Court to give me an opportunity to present my petition in orderly manner and extend the due date to December 16, 2018.
