Good-Cause shown, with regard to and in support of the above Application Request for Extension of Time, Petitioner/ Appellant/ Plaintiff *in pro-se* states that:

a)- On 01/16/2019, the *En-banc* court of the District of Columbia Court of Appeals by its Clerk notice, and an Order of panel denied Appellant's/ petitioner's rehearing petition; so

-the 90-days statutory jurisdictional requirement that the petitioner shall file petition for Writ of Certiorari with the U.S. Supreme Court still has not expired, and the U.S. Supreme Court has jurisdiction. Also,

-as required by Rule 13.5, this application for Extension of Time is submitted to the court more than 10-days before the date the petition is due, (04/16/2019). Also,

b)- As required a copy of order(s)/ decision(s) of the D.C. Circuit, which petitioner believes are based on misinterpreting and on erroneous assumptions, categorical ignorance, and/or as usual continuing injudicious operations, issued on:

-01/16/2019, notice by the clerk of the *En-Banc* court denial of rehearing;

-01/16/2019, panel's order of denial of rehearing;

-06/22/2018, panel's order, denial and dismissal;

-02/09/2018, clerk's order converting appeal to 'petition for writ of mandate'; also

-01/24/2018, the lower U.S. district court irrational Order by district judge Timothy J. KELLY/ TJK, (stamped una/ unassigned), remanding the case back to D.C. Superior Court; while the case had been REMOVED by plaintiff/ petitioner from D.C. Superior Court, (state court), to U.S. District Court, (federal court), which has jurisdiction, and that plaintiff had the right to choose the forum to hear/ file his legal action. Together with
