PETITION TO EXCEED WORD/PAGE LIMITS

PURSUANT TO RULE 33.1(d) and 33.2(b)

The Petitioner, MARK ELLIOTT, in pro se, respectfully asks that this Court grant this petition and/or application to exceed word and/or page limits and further states:

1. That on October 9, 2018 this Court denied Petitioner a Writ of Certiorari.

2. That on October 29, 2018 Petitioner sent, by commercial carrier, a Petition For Rehearing to this Court.

3. That this Court received Petitioner's Petition For Rehearing on November 1, 2018.

4. That on March 29, 2019 this Court returned Petitioner's Petition for failure to comply with the 15 page limitation set out in Rule 33.2(b).

5. That Petitioner read Rule 44 regarding Rehearing. However, being a layman to the law Petitioner was unaware, until notification from this Court, that Rule 33.2(b)—a rule titled in part: 8 1/2 by 11-Inch Paper Format, set out a 15 page limit for rehearing petitions.


